DECISION OF THE MANAGEMENT BOARD AMENDING THE MB DECISION 06-2005 OF 14 JUNE 2005 ADOPTING IMPLEMENTING RULES FOR THE AGENCY'S FINANCIAL REGULATION

THE MANAGEMENT BOARD,

- Having regard to the Regulation (EC) No 1592/2002 of the European Parliament and of the Council of 15 July 2002 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency, hereinafter called the "EASA Regulation"¹, and in particular Articles 52 and 53 thereof,
- Having regard to Council Regulation (EC, Euratom) No 1605/2002 of 25 June 2002 on the Financial Regulation applicable to the general budget of the European Communities, hereinafter called "General Financial Regulation", and in particular Article 185(1) thereof,²
- Having regard to the Commission Regulation (EC, Euratom) No 2343/2002 of 23 December 2002 on the Framework Financial Regulation for the bodies referred to in Article 185 of Council Regulation (EC, Euratom) No 1605/2002 on the Financial Regulation applicable to the general budget of the European Communities, hereinafter called the "Framework Regulation"³
- Having regard to the Commission Regulation (EC) No 593/2007 of 31 May 2007 on the fees and charges levied by the European Aviation Safety Agency ⁴, hereinafter called the "Fees and Charges Regulation", and in particular Article 3 thereof,
- Having regard to Management Board Decision 09-2003 of 26 August 2003 adopting the Agency's financial regulation, hereinafter the "Agency's Financial Regulation",
- Having regard to Management Board Decision 14-2007 amending the MB Decision 09-2003 of 26 August 2003: Financial Regulation of the European Safety Agency, and in particular the amended article 19.1a,

Decision

Whereas:

- (1) The European Aviation Safety Agency, hereinafter referred to as "the Agency", has legal personality and hence its own budget covered by specific financial rules,
- (2) The Management Board of the Agency has accordingly adopted the Agency's own Financial Regulation which is based on the Framework Regulation,
- (3) The EASA Regulation lays down the sources of revenue of the Agency, including fees and charges levied by the Agency,
- (4) According to Article 3 of the Fees and Charges Regulation the fees constitute assigned revenue in accordance with the Article 63 of EASA Regulation⁵,
- (5) As the list of earmarked revenue has been completed in article 19 in the "Agency's Financial Regulation" in accordance with the revised article 18 (1) of the General Financial Regulation⁶,
- (6) The Agency's Implementing Rules should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Article 7 of the Implementing Rules for the Financial Regulation of the European Aviation Safety Agency, is amended as follows:

a) In paragraph 2 the following is added:

"Except for the assigned revenue from fees and charges,... "

b) A new paragraph 3 is added:

"Appropriations corresponding to assigned revenue from fees and charges may be made available as soon as the amount receivable has been estimated, referred to in article 3, paragraph 3 of the Fees and Charges Regulation."

Article 2

Article 51 of the Implementing Rules for the Financial Regulation of the European Aviation Safety Agency, is amended as follows:

In paragraph 2 the following is added:

"..., except in the case referred to in article 7, paragraph 3."

Article 3

These rules shall enter into force on the day following its adoption by the Management Board of the Agency.
