### **Background**

The objective of RMT.0720 is to efficiently contribute to the protection of the aviation system from cyberattacks and their consequences.

As an important milestone of this regulatory activity, on 27 May 2019 the Agency has published NPA 2019-07 proposing the introduction of provisions for the management of information security risks related to those information systems used in civil aviation. These provisions shall apply to competent authorities and organisations in all aviation domains (i.e. design, production, management of continuing airworthiness, maintenance, air operations, aircrew, air traffic management/air navigation services (ATM/ANS), and aerodromes), include high-level, performance-based requirements, and shall be supported by acceptable means of compliance (AMC), guidance material (GM), and industry standards.
