Background

In September 2018, EASA launched an external evaluation on the applicable regulations related to the initial and recurrent training, licence issuance, competence assessment by instructors and checking by examiners. The objective of the assessment is to make an independent and evidence-based assessment of the main results achieved since the rules are in place, and to outline major issues

which EASA has to address to ensure a high and uniform level of safety and to meet the modern aviation challenges.

The evaluation is performed by a consultant who was requested to collect data from the competent authorities, industry members, pilots, instructors, examiners, training organisation and other interested stakeholders. More than 600 people/organisations were consulted to evaluate whether the rules are fit for purpose and how they could be improved.

Aim of the workshop

EASA is organising a workshop to present the conclusions and recommendations, stemming from the evaluation, which will focus on professional and non-professional pilots, training organisations and authorities.

The workshop provides an excellent opportunity for the Advisory Bodies and other stakeholders to verify the conclusions of the evaluation, to discuss and outline the way forward.

Target audience

The workshop is addressed to members of the EASA advisory bodies, authorities of the Member States, representatives of the industry and representatives of interest groups, involved in the domain of flight crew licensing, training, testing and checking.
