Background:

AMERICAN CHAMPION AIRCRAFT CORPORATION is the holder of European Aviation Safety Agency ("EASA") Type Certificate No. EASA.IM.A.298 for the Bellanca and Champion 8 aircraft series issued on the basis of Federal Aviation Administration ("FAA") Type Certificate No. A21CE and EASA Type Certificate No. EASA.IM.A.297 for the Bellanca and Champion 7 aircraft series issued on the basis of FAA Type Certificate No. A-759.

According to Article 7 (2) in conjunction with Table 6 of Part 1 of the Annex to Commission Regulation (EU) No. 319/2014¹ holders of EASA Type Certificates are required to pay an annual fee related to the certification tasks carried out by the Agency for the purpose of maintaining the EASA Type Certificate.

AMERICAN CHAMPION AIRCRAFT CORPORATION failed to fulfil the payment obligations imposed by Commission Regulation (EU) No. 319/2014.

Due to this non-compliance, EASA published on the Agency's website the <u>EASA Certification information 2018-08</u>, dated 24th April 2018, informing about the Agency's intent to revoke EASA Type Certificates No. EASA.IM.A.298 for the Bellanca and Champion 8 aircraft series and No. EASA.IM.A.297 for the Bellanca and Champion 7 aircraft series.

Meanwhile, EASA received full payment of the outstanding amount. With that, AMERICAN CHAMPION AIRCRAFT CORPORATION fulfilled the payment obligations imposed by Commission Regulation (EU) No. 319/2014.

Therefore, EASA no longer proceeds with the revocation of EASA Type Certificates No. EASA.IM.A.298 and No. EASA.IM.A.297. Consequently, the afore-mentioned EASA Type Certificates remain valid.
