# EXPLANATORY NOTE

## **CS-ETSO Amendment 3**

Executive Director Decision 2008/012/R amends Executive Director Decision No. 2003/10/RM of 24 October 2003 as last amended by Executive Director Decision No. 2007/017/R of 25 December 2007 (CS-ETSO Amendment 2).

This Amendment 3 of CS-ETSO (European Technical Standard Orders) incorporates the output from the following 2 Agency rulemaking tasks:

In response to both CRD 2007-10 and 2007-14 no substantive reactions were received.
