CS-ETSO Amendment 2

Executive Director Decision 2007/017/R amends Executive Director Decision No. 2003/10/RM of 24 October 2003 as last amended by Executive Director Decision No. 2006/04/R of 11 July 2006 (CS-ETSO Amendment 1).

This Amendment 2 of CS-ETSO: European Technical Standard Orders, incorporates the output from the following EASA rulemaking task:

The Agency did not receive reactions with respect to the content of CRD 14-2005.

EDITORIAL CORRECTIONS IN AMENDMENT 2

In addition to the changes that came out of the above NPA, this Amendment 2 of CS-ETSO also incorporates changes aiming to remove certain inconsistencies identified in ETSO-C151(b) caused by incorrect transposition of JAR-TSO at Amendment 5.

Article 13 of the Basic Regulation requires that the documents issued by the Agency, including certification specifications shall be updated as necessary.

ETSO-C151(b) APPENDIX 1

In the title of Appendix 1 "as amended by JAA" is changed to "as amended by EASA".

Justification:

Changes were introduced by EASA during the initial transposition into CS-ETSO.

CS-OPS 1.665 and CS-OPS 1 are respectively replaced by JAR-OPS 1.665/EU-OPS 1.665 and JAR-OPS 1/ EU-OPS 1.

Justification:

At the time of transposition of JAR-TSO into CS-ETSO the reference to JAR-OPS was accidentally replaced by a reference to CS-OPS. In the mean time EU-OPS has been adopted in the European Community framework. EU-OPS will supersede JAR-OPS in the near future. Both JAR-OPS and the EU-OPS are therefore referenced.
