EXPLANATORY NOTE

CS-27 Amendment 3

1. GENERAL

Executive Director Decision 2012/021/R amends Decision No 2003/15/RM of 14 November 2003 (CS-27 Initial Issue) as last amended by Executive Director Decision 2008/09/R of 17 November 2008 (CS-27 Amendment 2). It represents Amendment 3 of CS-27: Small Rotorcraft, and incorporates the output from the following EASA rulemaking task:

The Notice of Proposed Amendment (NPA) has been subject to consultation in accordance with Article 52 of the Basic Regulation¹ and Article 15 of the Rulemaking Procedure established by the Management Board². For detailed information on the proposed changes and their justification please consult the above NPA which is available on the Agency's website³.

The Agency has addressed and responded to the comments received on each of the NPAs. The responses are contained in a comment-response document (CRD) which has been produced for this NPA (CRD 2010-04) and which is also available on the Agency's web-site.

2. CRD REACTIONS

In response to the CRD 2010-04, the Agency received no substantive reactions.

3. EDITORIAL CHANGES

Minor editorial errors which have been identified are corrected as follows (See 'Change Information' for full details):

- a) <u>JAR 27.2 Special Retroactive Requirements</u> Change to numbering and reference to subsequent amendments added.
- b) <u>CS 27.547 Main Rotor Structure</u> 27.547(b) deleted to re-align with FAA Part 27. (References to CS 27.547 within CS 27.549 and CS 27.1521 also amended)
- c) <u>CS 27.865 External Loads</u> Amend subparagraph (f) by adding text. Text in JAA NPA 27-13 was not correctly transposed by the JAA in JAR-27 Am.2 (May 2001), creating a wording difference with FAR Part 27.
- d) <u>CS 27.1401</u> The equation in CS 27.1401(c) is incorrectly placed. It is now moved under point (e).
