OF THE EXECUTIVE DIRECTOR OF THE AGENCY**

of 19th July 2012

**Repealing Decision No 2004/02/CF of the Executive Director of the Agency
of 10 December 2004 on the acceptance of certification findings made by
Transport Canada, Civil Aviation Department (TCCA) for products designed
in Canada**

THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Regulation (EC) No 216/2008 of the European Parliament and of the Council of 20 February 2008 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency, and repealing Council Directive 91/670/EEC, Regulation (EC) No 1592/2002 and Directive 2004/36/EC¹, and in particular Article 12 thereof,

Having regard to the Agreement on civil aviation safety between the European Union and Canada² (hereinafter referred to as "the Agreement"),

Having regard to the Technical Implementation Procedures for airworthiness and environmental certification³.

WHEREAS:

- (1) The Agreement has been signed on 6 May 2009 and entered into force on 26 July 2011.
- (2) The Agreement establishes principles and arrangements in order to enable the reciprocal acceptance of technical findings and approvals issued by either Party's Competent Authorities in the fields covered by this Agreement.
- (3) The scope of the Agreement covers among others the airworthiness approval and monitoring of civil aeronautical products including the continuing airworthiness of in-service aircraft, the approval and monitoring of production and manufacturing facilities and the environmental testing and environmental approval of civil aeronautical products.

- (4) TCCA and the Agency adopted Technical Implementation Procedures for Airworthiness and Environmental Certification that define how the Parties will implement, and work in order to achieve the objectives set out in the Agreement and its Annexes.
- (5) The approval of changes, repairs and the conditions for the acceptance of alternative means of compliances are addressed by the relevant provisions established by the Agreement and the Technical Implementation Procedures.

HAS DECIDED AS FOLLOWS:

Article 1

Repeal

Decision No 2004/02/CF of the Executive Director of the Agency of 10 December 2004 on the acceptance of certification findings made by Transport Canada, Civil Aviation Department (TCCA) for products designed in Canada is hereby repealed.

Such repeal shall not affect the validity of any Agency approval under the conditions of Decision No 2004/02/CF.

Article 2

Publication


This Decision shall be published in the Official Publication of the Agency.
