# 2021/012/R

## of 14 September 2021

## issuing the following:

Issue 2 of the Certification Specifications for Operational Suitability Data (OSD) Flight Crew Data

'CS-FCD — Issue 2'

THE EXECUTIVE DIRECTOR OF THE EUROPEAN UNION AVIATION SAFETY AGENCY (EASA),

Having regard to Regulation (EU) 2018/1139<sup>1</sup>, and in particular Article 104(3)(a) thereof,

Having regard to Regulation (EU) No 748/2012<sup>2</sup>, and in particular points 21.B.5(b) and 21.B.70 of Annex I (Part 21) thereto,

#### Whereas:

- (1) EASA shall, pursuant to Article 76(3) of Regulation (EU) 2018/1139, issue certification specifications (CSs) and acceptable means of compliance (AMC), as well as guidance material (GM), for the application of Regulation (EU) 2018/1139 and of the delegated and implementing acts adopted on the basis thereof.
- (2) Certification specifications (CSs) are non-binding technical standards issued by EASA which indicate the means to demonstrate compliance with Regulation (EU) 2018/1139 and the delegated and implementing acts adopted on the basis thereof, and which are used by persons and organisations for the purpose of certification.
- (3) Guidance material (GM) is non-binding material issued by EASA, which helps to illustrate the meaning of delegated or implementing acts, certification specifications (CSs) or acceptable means of compliance (AMC), and which is used to support the interpretation of Regulation (EU) 2018/1139, the delegated and implementing acts adopted on the basis thereof, CSs and AMC.

Regulation (EU) 2018/1139 of the European Parliament and of the Council of 4 July 2018 on common rules in the field of civil aviation and establishing a European Union Aviation Safety Agency, and amending Regulations (EC) No 2111/2005, (EC) No 1008/2008, (EU) No 996/2010, (EU) No 376/2014 and Directives 2014/30/EU and 2014/53/EU of the European Parliament and of the Council, and repealing Regulations (EC) No 552/2004 and (EC) No 216/2008 of the European Parliament and of the Council and Council Regulation (EEC) No 3922/91 (OJ L 212, 22.8.2018, p. 1) (https://eurlex.europa.eu/legal-content/EN/TXT/?gid=1535612134845&uri=CELEX:32018R1139).

- (4) With Decision 2014/008/R of 31 January 2014, the Executive Director issued the Certification Specifications for Operational Suitability Data (OSD) for Flight Crew Data (CS-FCD).
- EASA shall, pursuant to Article 4(1)(a) of Regulation (EU) 2018/1139, reflect the state of the art (5) and the best practices in the field of aviation and update its decisions, taking into account worldwide aviation experience and scientific and technical progress in the respective fields.
  - CS-FCD is updated to clarify the type rating evaluation process as well as to improve its overall content based on lessons learned since its first issuance and the introduction of the OSD into the EU regulatory framework in 2014. This update is expected to bring efficiency gains to said process and have a moderate safety benefit.
- (6) EASA, pursuant to Article 115(1)(c) of Regulation (EU) 2018/1139 and Articles 6(3), 7 and 8 of the EASA Rulemaking Procedure<sup>3</sup>, widely consulted the interested parties on the content of this Decision, and provided thereafter a written response to the comments received<sup>4</sup>,

HAS DECIDED:

#### Article 1

The Annex to this Decision is issued as Issue 2 of the Certification Specifications for Operational Suitability Data (OSD) Flight Crew Data.

#### Article 2

This Decision shall enter into force on the day following that of its publication in the Official Publication of EASA.
