THE EXECUTIVE DIRECTOR OF THE EUROPEAN UNION AVIATION SAFETY AGENCY (EASA),

Having regard to Regulation (EU) 2018/11391, and in particular Article 104(3)(a) thereof,

Having regard to Regulation (EU) No 965/2012², and in particular point ARO.GEN.120(a) of Annex II (Part-ARO) thereto,

Whereas:

- (1) EASA shall, pursuant to Article 76(3) of Regulation (EU) 2018/1139, issue certification specifications (CSs) and other detailed specifications (DSs), acceptable means of compliance (AMC), and guidance material (GM) for the application of Regulation (EU) 2018/1139 and of the delegated and implementing acts adopted on the basis thereof.
- (2) Acceptable means of compliance (AMC) are non-binding standards issued by EASA, which are used by persons and organisations to show compliance with Regulation (EU) 2018/1139 and the delegated and implementing acts adopted on the basis thereof.
- (3) Guidance material (GM) is non-binding material issued by EASA, which helps to illustrates the meaning of delegated or implementing acts or certification specifications and detailed specifications, and which is used to support the interpretation of Regulation (EU) 2018/1139, of

- (11) With Decision 2014/018/R of 24 April 2014, the Executive Director issued Acceptable Means of Compliance and Guidance Material to Annex VIII (Part-SPO) to Commission Regulation (EU) No 965/2012 ('AMC and GM to Part-SPO').
- (12) EASA shall, pursuant to Article 4(1)(a) of Regulation (EU) 2018/1139, reflect the state of the art and the best practices in the field of aviation and update its decisions taking into account worldwide aviation experience and scientific and technical progress in the respective fields.
- (13) Commission Implementing Regulation (EU) 2021/2237³ amended Regulation (EU) No 965/2012 as regards the requirements for all-weather operations. The new provisions, which shall apply from 30 October 2022, will modernise the EU aviation regulatory framework in the field of all-weather operations, enabling efficiency gains based on the latest technological advancements while maintaining a high level of safety in air operations. The new provisions incorporate into the EU legal framework the latest International Civil Aviation Organization (ICAO) Annex 6, Parts I, II, and III Standards and Recommended Practices (SARPs) on all-weather operations.

- (14) In this context, EASA has determined the need to amend the AMC and GM to Regulation (EU) No 965/2012 to facilitate the uniform implementation of the subject provisions.
- (15) EASA, pursuant to Article 115(1)(c) of Regulation (EU) 2018/1139, and Articles 4(2) and 6 of the EASA Rulemaking Procedure⁴, widely consulted the interested parties on the contents of this Decision, and provided thereafter written responses to the comments received during the public consultation phase⁵,

HAS DECIDED:

Article 1
