Background:

On the date mentioned in the table above, the European Union Aviation Safety Agency (EASA) issued the above mentioned ETSO Authorizations for the purpose of recognition of U.S. Federal Aviation Administration (FAA) TSO Authorizations.

On the 2nd of March 2016 the Agreement between the USA and the EU on cooperation in the regulation of civil aviation safety has been amended by incorporating text additions and changes to the relevant paragraphs concerning the reciprocal automatic acceptance of ETSO/TSO Articles and approvals.

On the 06th of December 2022, FAA notified EASA of a transfer of ownership and change of address of the subject TSOA from B/E Aerospace, Inc., located at 5349 S. Emmer Drive, New Berlin, WI, 53151 to Goodrich Corporation, 3445 S. 5th Street, Suite 180, Phoenix, AZ 85040.

As result of such transfer, the FAA TSOA Certificate have been re-issued.

According to the Bilateral Agreement US-EU and policies shared with FAA, in case of TSO transfer with reissue of TSO letters in the name of the new holder, EASA will proceed by revoking the related ETSO Authorizations as the conditions for which were validated no longer exist.

In virtue of the mutual acceptance of TSO/ETSO the re-issued TSOs are considered equivalent to EASA emitted ETSOA. Equipment can be exported to EU with relevant FAA authorization release form. Since revocation of ETSOAs, ETSO Marking is non more required.

Equipment produced and marked before the 06th of December 2022 can remain in service under the existing conditions.
