Technical Implementation Procedures (TIP) for Airworthiness and Environmental Certification Between the Civil Aviation Administration of China and the European Union Aviation Safety Agency, Chapter 7 (<u>link</u>):

"For civil aeronautical products exported from China (...), the following export airworthiness approvals are recognised and accepted when issued in a form and manner prescribed by the Exporting Party through its Competent Authority, as follows:

- 1) for complete aircraft only, an Export Certificate of Airworthiness (CAAC Form AAC-157 (...)) issued by the Exporting Party for new aircraft or the Competent Authority of the SoR for used aircraft; and
- 2) for a new civil aeronautical product other than a complete aircraft, an Authorised Release Certificate (Airworthiness Approval Tag) (CAAC Form AAC-038 (...)) issued by the Competent Authority or the accepted production certificate holder."
