#### Issue:

ATA MSG-3 Volume I and Volume II documents still refer to a "User's Guide" as alternative to a PPH.

#### **Problem:**

The term "User's Guide" has been introduced in the ATA MSG-3 revision 1, to give an alternative to the "Policy and Procedure Handbook".

During the years, many different titles have been used for the document which establish the policy and procedures for the development of the initial minimum schedule maintenance/inspection requirements.

#### Currently, "User's Guide" is mentioned in Paragraph 2-1-2.3:

Assumptions made during the analysis, that can result in a change to the analysis, are to be recorded.

• Assumptions applying to the program as a whole, and not only to an individual MSG-3 analysis, are to be documented in the appropriate "Policy and Procedures Handbook" or "User's Guide." As a minimum, this applies to statements concerning anticipated average annual utilization, the
