### **Information**

A workshop on Part M hosted by Europe Air Sports (EAS) and jointly organised with EASA will be held in Cologne<sup>1</sup> on the 4<sup>th</sup> and 5<sup>th</sup> November 2005. This workshop aims to facilitate a dialogue with the European recreational aviation community<sup>2</sup> with regards to the Agency's latest developments related to Part-M requirements.

All EU civil aviation authorities will be invited as well as EAS, AOPA and ECOGAS and other interested stakeholders. Registrations will be accepted on a first-come-first served basis.
