Acceptable means of compliance and guidance material to the Annexes to Commission Regulation (EU) No 1321/2014 — Issue 2

EXECUTIVE SUMMARY

Following the recast of Commission Regulation (EC) No 2042/2003 of 20 November 2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks, this Decision is issued in order to provide stakeholders with a consolidated version of the related acceptable means of compliance (AMC) and guidance material (GM) to the Annexes to Regulation (EU) No 1321/2014 of 26 November 2014, as last amended by Regulation (EU) 2015/1088 of 3 July 2015.

Decision 2003/19/RM of the Executive Director of the Agency of 28 November 2003 on acceptable means of compliance and guidance material to Commission Regulation (EC) No 2042/2003 is hereby recasted. This includes introduction of changes in writing conventions and references to other regulations, as well as correction of various errors.

1. Procedural information

1.1. The rule development procedure

The European Aviation Safety Agency (hereinafter referred to as the 'Agency') developed Decision 2015/029/R in line with Regulation (EC) No $216/2008^1$ (hereinafter referred to as the 'Basic Regulation') and the Rulemaking Procedure².

The process map on the title page summarises the major milestones of this regulatory activity.
