amending Acceptable Means of Compliance and Guidance Material to Part-ORO, Part-CAT,
Part-NCC, and Part-SPO of Commission Regulation (EU) No 965/2012

'AMC and GM to Commission Regulation (EU) 2015/2338<sup>1</sup> on flight recorders, underwater locating devices and aircraft tracking systems (first set)'

THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Regulation (EC) No 216/2008<sup>2</sup>, and in particular Article 38(3)(a) thereof,

Having regard to Commission Regulation (EU) No 965/2012<sup>3</sup> of 5 October 2012 and in particular ARO.GEN.120(a) of Annex II thereto,

## Whereas:

(1) The Agency shall, pursuant to Article 18(c) of Regulation (EC) No 216/2008, issue certification specifications and acceptable means of compliance, as well as guidance material, for the application of Regulation (EC) No 216/2008 and its implementing rules.

Regulation (EC) No 216/2008 of the European Parliament and of the Council of 20 February 2008 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency, and repealing Council Directive 91/670/EEC, Regulation (EC) No 1592/2002 and Directive 2004/36/EC (OJ L 79, 19.3.2008, p. 1).

- (2) Acceptable means of compliance are non-binding standards adopted by the Agency which may be used by persons and organisations to demonstrate compliance with Regulation (EC) No 216/2008 and its implementing rules; when acceptable means of compliance are complied with, the related requirements of the implementing rules are met.
- (3) Guidance material is non-binding material developed by the Agency which helps to illustrate the meaning of a requirement or specification and is used to support the interpretation of Regulation (EC) No 216/2008, its implementing rules, certification specifications and acceptable means of compliance.
- (4) With Decision 2014/017/R of 24 April 2014, the Executive Director issued Acceptable Means of Compliance and Guidance Material to Part-ORO of Regulation (EU) No 965/2012.
- (5) With Decision 2014/015/R of 24 April 2014, the Executive Director issued Acceptable Means of Compliance and Guidance Material to Part-CAT of Regulation (EU) No 965/2012.
- (6) With Decision 2013/021/R of 23 August 2013, the Executive Director issued Acceptable Means of Compliance and Guidance Material to Part-NCC of Regulation (EU) No 965/2012.
- (7) With Decision 2014/018/R of 24 April 2014, the Executive Director issued Acceptable Means of Compliance and Guidance Material to Part-SPO of Regulation (EU) No 965/2012.
- (8) The Agency shall, pursuant to Article 19(2) of Regulation (EC) No 216/2008, reflect the state of the art and the best practices in the fields concerned and update its decisions taking into account worldwide aircraft experience in service, and scientific and technical progress.
- (9) The Agency issued on 20 December 2013 Notice of Proposed Amendment (NPA) 2013-26 on 'Amendment of requirements for flight recorders and underwater locating devices'<sup>4</sup>. NPA 2013-26 contains draft amendments to the implementing rules of Part-CAT, Part-NCC and Part-SPO, as well as draft amendments to AMC and GM for the implementing rules of Part-ORO, Part-CAT, Part-NCC and Part-SPO.
- (10) The Agency issued on 5 May 2014 Comment-Response Document (CRD) 2013-26 and Opinion No 01/2014. CRD 2013-26 contains a revised version of the draft AMC and GM presented in NPA 2013-26.
- (11) Based on Opinion No 01/2014, CRD 2013-26 and NPA 2013-26, the European Commission prepared and published Commission Regulation (EU) 2015/2338 amending Regulation (EU) No 965/2012 as regards requirements for flight recorders, underwater locating devices and aircraft tracking systems.
- (12) The Agency, pursuant to Article 52(1)(c) of Regulation (EC) No 216/2008 and Articles 5(3), 6 and 7 of the Agency's Rulemaking Procedure<sup>5</sup>, has widely consulted interested parties on the matters which

## Article 1

## Article 3

The Annex to Decision 2013/021/R (AMC and GM to Part-NCC) of the Executive Director of the European Aviation Safety Agency of 23 August 2013 is amended as laid down in Annex III to this Decision.

## Article 4

The Annex to Decision 2014/018/R (AMC and GM to Part-SPO) of the Executive Director of the European Aviation Safety Agency of 24 April 2014 is amended as laid down in Annex IV to this Decision.

#### Article 5

This Decision shall enter into force on the day following that of its publication in the Official Publication of the Agency.
