DECISION 2013/024/ R OF THE EXECUTIVE DIRECTOR OF THE AGENCY

of 10 September 2013

amending Appendix 1 'Aircraft type ratings for Part-66 aircraft maintenance licence' to Annex IV 'Acceptable Means of Compliance to Part-66' of Decision 2003/19/RM of the Executive Director of the Agency of 28 November 2003.

'Aircraft type ratings for Part-66 aircraft maintenance licences'

THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to the Regulation (EC) No 216/2008 of the European Parliament and of the Council of 20 February 2008, on common rules in the field of civil aviation and establishing a European Aviation Safety Agency¹-(hereinafter referred to as 'the Basic Regulation'), and in particular Articles 38(3)(e) and 38(3)(i) thereof,

WHEREAS:

- (1) Appendix I 'Aircraft type ratings' of Annex IV 'Acceptable Means of Compliance to Part-66' of Decision No 2003/19/RM² (hereinafter referred to as 'Part-66 AMC Appendix I') is required to be up to date to serve as a reference for the National Aviation Authorities.
- (2) To achieve this requirement, the text of Part-66 AMC Appendix I should be amended regularly to include new aircraft type ratings.
- (3) The regular amendment of Part-66 AMC Appendix I is considered a permanent rulemaking task for the European Aviation Safety Agency (hereinafter referred to as the 'Agency'). This Decision contains an amendment of Part-66 AMC Appendix I. The last amendment of Appendix I was the Decision No 2012/004/R of 19 April 2012.
- (4) The Agency, pursuant to Article 52(1)(c) of the Basic Regulation and Articles 5(3) and 6 of the Rulemaking Procedure³, has widely consulted interested parties on the matters which are the subject of this Decision and has provided thereafter a written response to the comments received⁴.
