**DECISION N° 01-2016** 

# of 7 June 2016

# on the composition of the Stakeholders Advisory Body (SAB)

THE MANAGEMENT BOARD OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Regulation (EC) No 216/2008 <sup>1</sup> of the European Parliament and of the Council of 20 February 2008 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency, hereinafter referred to as the 'Basic Regulation', and in particular Article 33(4) thereof,

Considering that persons and organisations subject to the rules elaborated, or the powers exercised by the European Aviation Safety Agency, shall be entitled to present their views on its functioning, efficiency and achievements and so assist the Management Board in exercising its control,

Having regard to the MB Decision 20-2015 establishing the Stakeholders Advisory Body (SAB),

Considering that the SAB membership should ensure a fair and exhaustive representation of all persons and organisations, including small and medium size companies, subject to the EASA Regulation and its implementing rules, and that the non-EU Industry Associations will participate as Members with the right to vote on all matters except the SAB chairmanship and the SAB's functions related to Articles 33(4) and 34(3) of the Basic Regulation,

Having regard to the suggestions made by the interested parties themselves, and in particular the EASA Advisory Board (EAB) and Safety Standards Consultative Committee (SSCC) members,

HAS DECIDED TO AGREE ON THE FOLLOWING SAB COMPOSITION:

Regulation (EC) No 216/2008 of the European Parliament and of the Council of 20 February 2008 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency, and repealing Council Directive 91/670/EEC, Regulation (EC) No 1592/2002 and Directive 2004/36/EC (OJ L 79, 19.3.2008, p. 1).
