Invitation to the 2017 EASA MRB WORKSHOP

Dear All,

I'm pleased to inform you that we are officially launching the **2017 EASA MRB WORKSHOP**, open for the participation of EU Operators/MROs along with Manufacturers.

Scope of this meeting will be:

- To ensure all MRB activities are communicated: The IMPS; Regulatory Agreements for reciprocal acceptance (BASA), DOA privileges for MRB process, Level Of Involvement (LoI), Level Of Participation (LoP), MPIG & IMRBPB activities, etc.
- To provide information on Candidate Issue Papers (CIPs) that will be presented and discussed at the IMRBPB meetings and discuss those CIPs for which a strong support from EASA is deemed necessary by the industry or for which EASA is looking for Industry consensus. The adoption of a CIP by the IMRBPB will lead to amendments in the MSG-3 tool, or changes to the processes used by the international Regulatory Authorities (IMPS).
- Related MRB items such as MPD, AMP, ICAs, Legacy Program items, etc. based on Industry inputs.

It should be clear that the main scope of this meeting is the MRB approval process, the MSG-3 tool and any related topics, but not topics related to the implementation of scheduled maintenance tasks in Maintenance Programmes at national level, for which dedicated Standardisation meetings are held.

The workshop will take place on **April 4-6 2017** at the new EASA headquarters in Cologne (first day from 13:00 and last day until 13:00 in order to facilitate arrival/departure).

We will reserve a meeting room for the morning of the April 4th in order to allow the Industry to have a caucus without EASA (specific Agenda will be prepared by the Industry if necessary).

Please note this email is sent to ISC/WG members that could be part of the same organization and you might internally coordinate your participation/ideas/suggestions.

In order to efficiently organize the meeting and to define the agenda we would appreciate you to:

- **Confirm the participation as soon as possible**
- **Send any items for the agenda or any ideas for the meeting by the 15th of February 2017**

Mr Antonino LEVANTINO will be the focal point for the organisation of this meeting.


Following an internal review we will evaluate your proposals in order to define the final Agenda.
