# 2.Problem / Statement of issue and justification; reason for regulatory evolution (regulatory tasks):

Applicability paragraph (CS-VLA 1) limits VLA aircraft operations to day VFR only. Comments were received on draft CS-VLA, when published for consultation, suggesting that the current limitation to day VFR operations is over restrictive and does not reflect the current technical developments in this and neighbouring categories of aircraft (e.g. microlights). This puts European VLA aircraft into disadvantage in competition with their foreign competitors. The above comments were deferred by the EASA CS Review Group, however the merit of these concerns was recognized and Agency was recommended to review the matter with urgency.

#### 3.Objective:

The aim is to consider and define additional requirements that would provide compensating factors allowing certification of VLA aircraft to night VFR operations.

# 4. Specific tasks and interface issues (Deliverables):

- To review and consider the comments related to this issue as published in the EASA Comment Response Document (CRD) for CS-VLA
- To define additional requirements that would provide compensating factors allowing certification of VLA aircraft to night VFR operations.

To deliver a draft EASA NPA, accompanied with proper justification (Explanatory Note), to amend CS-VLA to allow night VFR operations.

### 5. Working Methods:

The initial meeting should be held early enough so as to allow to meet the task within the required timescale:

Meetings shall be held at the Agency's head office or at the Central JAA depending where the Agency support to the group is provided.

The draft EASA NPA should be delivered before 31 October 2004.
