Description

EASA is pleased to invite interested stakeholders to an information session on the material proposed in the recent published [NPA2025-06](#), as a result of [RMT0743](#) subtask 1 ('Regular update of the AMC and GM associated with the conformity assessment framework for ATM/ANS equipment'). This session aims to provide an overview of the proposed AMC/GM.

The proposed regulatory material is based on EASA's experience gained during the initial implementation of the related regulatory framework when issuing design or production organisation approvals, during the development of procedures for the certification of ATM/ANS equipment, and feedback received from stakeholders since the adoption of the regulatory framework.

The information session will facilitate understanding of the proposed material and subsequent consultation, which is open until 23/01/2026.
