### **Description**

The highly successful EASA ETSO workshop is back for the 11<sup>th</sup> time. It will be held on 17 & 18 June 2015 at the Pullman Hotel, Helenenstr.14 in Cologne. The workshop is scheduled for two full days, a detailed agenda will be provided nearer the time.

Since the first workshop in 2004, this event has grown in popularity and attendance. It has become a regular forum for the worldwide community of ETSO/TSO manufacturers, installers and operators, where topics of common interest in the various fields of aviation equipment are presented and discussed, aiming at updating participants, and getting their feedback on industry and authority initiatives concerning operational, design, manufacturing and regulatory

matters with the common scope of fostering safety. Besides EASA, FAA, TCCA also representatives from CAAC and ANAC may be present.

According to the feedback from the last ETSO workshop, we have planned to include a general session, covering topics of interest for all participants, like updates from Rulemaking, ADOA, foreign authorities, and two split sessions with more detailed discussions in the domain of avionics as well as seats/mechanical systems. Copies of all presentations held as well as additional background material will be made available on the EASA website for download after the workshop; considering the environmental impact we have decided not to print any hand-outs this year.
