**Description**

The EASA Flight Data Monitoring (FDM) Conference 2017 promotes the implementation and development of the most advanced use of Flight Data and related analysis techniques for the improvement of Aviation Safety.

The target participant group includes operators, aircraft manufacturers, universities and research organisations, regulators, flight crew associations and FDM software vendors from the world's leading organisations in the FDM field.

The conference's presentations and discussions will focus on lessons learned by operators. Subject matter will cover the capturing and monitoring of safety issues, the analysis techniques being used, the merging of flight data with other sources of data and the integration of it in SMS programs within the airlines. The most up-to-date analysis techniques and subjects like Big Data and Machine Learning will be presented and are expected to further enrich discussions.

This conference is primarily for professionals working in FDM. At least a basic knowledge of FDM will be required in order to understand the presentation content.
