EXPLANATORY NOTE

CS-ETSO Amendment 5

Executive Director Decision 2009/015/R amends Executive Director Decision No. 2003/10/RM of 24 October 2003 on Certification Specifications, Including Airworthiness Codes and Acceptable Means of Compliance, for European Technical Standard Orders "CS-ETSO" as last amended by Executive Director Decision No. 2009/014/R of 14 October 2009.
