2016/006/R

of 25 April 2016

adopting amendment 10 of Decision No 2003/10/RM of the Executive Director of the Agency of 24 October 2003 on Certification Specifications for European Technical Standard Orders (CS-ETSO)

'Integrated Modular Avionics (IMA) platform and modules'

THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Regulation (EC) No 216/2008¹, and in particular Article 38(3)(a) thereof,

Having regard to Commission Regulation (EU) No 748/2012² and in particular 21.A.16A of Annex I (Part-21) thereto,

Whereas:

- (1) The Agency shall, pursuant to Article 18(c) of Regulation (EC) No 216/2008, issue certification specifications and acceptable means of compliance, as well as guidance material, for the application of Regulation (EC) No 216/2008 and its implementing rules.
- (2) Certification specifications are non-binding technical standards adopted by the Agency which indicate the means to demonstrate compliance with Regulation (EC) No 216/2008 and its implementing rules and which can be used by organisations for the purpose of certification.

- (3) With Decision No. 2003/10/RM of 24 October 2003, the Executive Director of the Agency adopted certification specifications for European Technical Standard Orders (CS-ETSO³).
- (4) The Agency shall, pursuant to Article 19(2) of Regulation (EC) No 216/2008, reflect the state of the art and the best practices in the fields concerned and update its decisions taking into account worldwide aircraft experience in service, and scientific and technical progress.
- (5) The Agency has determined the need to improve CS-ETSO with respect to equipment approval by issuing ETSO-2C153 to account for changes in technology and industry expectations in relation to integrated modular avionics (IMA).
- (6) The Agency, pursuant to Article 52(1)(c) of Regulation (EC) No 216/2008 and Articles 5(3), 6 and 7 of the Agency's Rulemaking Procedure⁴, has widely consulted interested parties on the matters which are the subject of this Decision and has provided thereafter a written response to the comments received⁵.

HAS DECIDED:

Article 1

Decision No. 2003/10/RM of the Executive Director of the Agency of 24 October 2003 is amended by including in its Annex the Annexes to this Decision.

Article 2

This Decision shall enter into force on 2 May 2016.
