

# 'AMC & GM to Part 21 Amendment 2 to Issue 2' 'Operational Suitability Data'

RELATED NPA/CRD 2009-01 - OPINION NO 07/2011 - RMT.0103 (21.039(b) - 31.01.2014

## EXECUTIVE SUMMARY

The European Commission has adopted Commission Regulation (EU) No 69/2014<sup>1</sup> amending Commission Regulation (EU) 748/2012 which allows the Agency to approve operational suitability data (OSD) as part of the type-certification process. It is necessary to support the above amendment by new Acceptable Means of Compliance (AMC) and Guidance Material (GM).

# **1.** Procedural information

#### 1.1. The rule development procedure

The European Aviation Safety Agency (hereinafter referred to as the 'Agency') developed ED Decision 2014/007/R in line with Regulation (EC) No  $216/2008^2$  and the Rulemaking Procedure<sup>3</sup>.

This rulemaking activity is included in the Agency's Rulemaking Programme for 2014 under RMT.0607  $(21.039(b))^4$ . The scope and timescale of the task were defined in the related Terms of Reference (see process map on the title page).

The draft text of this Decision has been developed by the Agency based on the input of the Rulemaking Group RMT 21.039a. All interested parties were consulted through NPA 2009- $01^{5}$ . 1011 comments were received from interested parties, including industry and national aviation authorities.

The Agency has reviewed the comments received on the NPA. The comments received and the Agency's responses are presented in the Comment-Response Document (CRD)  $2009-01^6$ .

The final text of this Decision with the AMC/GM has been developed by the Agency based on the input of the Review Group RMT 21.039(a) and focused consultation.

The process map on the title page summarises the major milestones of this rulemaking activity.

## **1.2.** Structure of the related documents

Chapter 1 contains the procedural information related to this task. Chapter 2 explains the core technical content. Chapter 3 provides references. The text of the AMC/GM is annexed to the ED Decision.

# 2. Explanatory Note

This amending Decision provides AMC/GM to Commission Regulation (EU) No  $748/2012^7$  of 3 August 2012 laying down, among others, requirements for certification of aircraft, as amended by Commission Regulation (EU) No 69/2014.

#### 2.1. Overview of the issues to be addressed

Commission Regulation (EU) 748/2012 is amended to introduce operational suitability data (OSD) into the aircraft type certification process.

It is necessary to support the above amendment by new Guidance Material.

#### 2.2. Objectives

The overall objectives of the EASA system are defined in Article 2 of Regulation (EC) No 216/2008. This proposal will contribute to the achievement of the overall objectives by addressing the issues outlined in Chapter 2. The specific objective of this proposal is, therefore, to maintain a high level of safety, to ensure proportionate rules where appropriate, and to warrant flexibility and efficiency for operators and authorities.

#### 2.3. Overview of the amendments

The Annex, Part 21, to Commission Regulation (EU) 748/2012, is amended by adding new points or adding the OSD into existing points. Some of these points are further explained in the Guidance Material. The main issues are the following:

In Part 21 a new point 21.A.15(d) is added explaining the content of OSD. Guidance Material was developed explaining which OSD elements apply to the various categories of aircraft and what the status will be of the OSD when used by the operators and training organisations.

The amended Part 21 acknowledges that the OSD may not be complete at the time of issuance of the type certificate. Guidance material explains that it is possible to have provisional data approved in the meantime to help the first operators.
