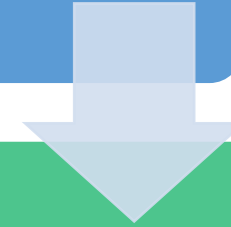

## Basic Regulation EU 2018-1139

- Article 98 requires the establishment of an advisory body representing the full range of interested parties affected by the work of the Agency, to be consulted by the EASA Management Board



## EASA Management Board Decisions

- Decision 20-2015 establishes the Stakeholders Advisory Body (SAB)
- Decision 01-2016 determines the composition of the SAB (representative associations grouped by sectors)



## SAB Rules of Procedure

- New version adopted Nov-2022, published Apr-2023
- Implementation to be completed this year.





## 2003 – EAB and SSCC

Strategy = EAB, EASA  
Advisory Board

Regulations = SSCC, Safety  
Standards Consultative  
Committees

EAB and SSCC not linked

## 2017- SAB - **Merging**
