closing rulemaking task RMT.0132 & RMT.0515 (27&29.027)

'Helicopter height-velocity (H-V) limitations'

THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Regulation (EC) No 216/2008¹, and in particular Article 38(3)(a) thereof,

Whereas:

- (1) The Agency shall, pursuant to Article 18(a) and (c) of Regulation (EC) No 216/2008, issue opinions addressed to the European Commission, and certification specifications, including acceptable means of compliance, as well as any guidance material for the application of Regulation (EC) No 216/2008 and its implementing rules.
- (2) When transferring the requirements of JAR-OPS 3 into Regulation (EU) 965/2012², the alleviation to allow helicopter flights to momentarily penetrate the H-V envelope during take-off and landing when operationally necessary was not transposed for all helicopters.
- (3) Operators have been granted exemptions according to Article 14(4) of Regulation (EC) No 216/2008 in order to carry on flying these helicopters.
- (4) The Agency issued Notice of Proposed Amendment 2014-19 proposing to amend Regulation (EU) No 965/2012 and Certification Specifications, in order to allow flights to penetrate the H-V envelope when operationally needed and to terminate the exemptions.
- (5) In view of the comments received and considering the internal deliberations that took place, the Agency decided to propose a change to Annex IV to Regulation (EC) No 216/2008, which is included in the proposal of the European Commission for a revision of Regulation (EC) No 216/2008 as proposed by Commissioner Violeta BULC (COM(2015) 613 final; 2015/0277 (COD))³. Should the proposal be adopted by the European Parliament and the Council,

HAS DECIDED:

Article 1

Rulemaking task RMT.0132 & RMT.0515 (27&29.027) 'Helicopter height-velocity (H-V) limitations' is hereby closed without issuing an opinion to amend Regulation (EU) No 965/2012² and without an amendment to CS-27 or CS-29.

Should the proposed amendment to Regulation (EC) No 216/2008 not be adopted by the European Parliament and the Council, the Agency will resume work on the above-mentioned rulemaking task.
