Context:

Rolls-Royce plc has made an application, dated 8th June 2018 to EASA for the transfer of all the EASA civil Type Certificates held by Rolls-Royce plc to Rolls-Royce Deutschland Ltd & Co KG.

Rolls-Royce Deutschland Ltd & Co KG has made accordingly an application, dated 8th June 2018 to EASA to extend the scope of their EASA Design Organisation Approval (ref. EASA.21J.065). Rolls-Royce Deutschland Ltd & Co KG is now deemed to be able to undertake the obligations under 21A.44 and for this purpose, has demonstrated its ability to qualify under the criteria of 21A.14 of the Annex (Part 21) to Regulation (EC) No 1702/2003.

As a consequence, EASA has accepted the transfer and re-issued the Type Certificate.

All Airworthiness Directives (ADs) related to these products are still applicable unless replaced or cancelled.
