PRIVACY STATEMENT

ECCAIRS System Management Ref # 101

1. What personal data do we collect?

ECCAIRS is a software suite accessible via web browser, allowing within the same platform on the one hand the collection of safety reports from organisations subject to Regulation 376/2014 by their respective Competent Authorities and on the other hand their sharing after processing at European level. Part of this processing involves the removal of any personal information from the reports by the authorities before they are shared.

It is to note, that EASA, being also one Competent Authority for a number of organisations has a duty like any other Authority an following the provisions set in EU reg 376/2014 (art 35), to remove all personal data from the reports it receives. Typically this data could be contained in the narrative text of the report.

In the context of the mandate given to EASA by DG Move to develop, maintain and host the ECCAIRS software suite, EASA is required to process personal data inherent to the definition of end-users of a computer system. This type of personal data is required to run the ECCAIRS system features related to the Identification and Access Management. It contains : Firstname, Surname, email address, Organisation.

2. For what purpose do we collect personal data and on which legal basis?

The ultimate goal of ECCAIRS is to assist National Aviation Authorities in collecting, sharing and analysing their safety information in order to improve public transport safety.

The Legal basis for collecting personal data is Articles 5(1)(a) and 5(1)(b) of Regulation (EU) 2018/1725.

Furthermore, ECCAIRS is directly related to two European Regulations:

- Regulation (EU) No 996/2010 of 20 October 2010 on the investigation and prevention of accidents and incidents in civil aviation,

- Regulation (EU) No 376/2014 of 3 April 2014 on the reporting, analysis and follow-up of occurrences in civil aviation.

ECCAIRS implements the safety data collection and dissemination requirements for these Regulations both in terms of occurrence reports as well as safety recommendations.

3. Who may receive your personal data?

EASA, only processes information related to user accounts accessible to Eccairs team at EASA. (Any personal data included in reports are deleted by the Competent Authority before these are transferred to ECR).

4. How long are your personal data kept?

User account remains active until its deactivation is requested by the relevant Member State.

The account will be deleted as soon as a user will introduce the request to the administrator, a notice will be communicated in that sense to the registered users.

The design of ECCAIRS also integrates this process as:

- *Contacting the administrator will be made possible through the online community portal*
- *Features have been developed to allow the total deletion of any user references from the system*

5. What are your rights?

You have the right to request from EASA access to and rectification or erasure of your personal data or restriction of processing.

EASA should provide information on action taken on a request within one month of receipt of the request. That period may be extended by two further months where necessary, taking into account the complexity and number of the requests.

A breach concerning your personal data should be communicated to you under certain circumstances. EASA should also ensure the confidentiality of electronic communications.

6. Who is the data controller and how to exercise your rights?

The Head of the Aviation Safety Unit (E.4) of DG MOVE is the Data Controller of the ECCAIRS 2 system.

To exercise the mentioned rights, you can contact the processor by sending an email to EASA: ECCAIRS-DP@easa.europa.eu.

If you consider your data protection rights have been breached, you can always lodge a complaint with the EASA's Data Protection Officer (dpo@easa.europa.eu).
