Within the Single European Sky framework, the European Commission has sent to EUROCONTROL a request for the development of a draft implementing rule on Standardised European Rules of the Air (SERA). Moreover, the extension of scope of EASA Basic Regulation¹ and in particular Annex Vb of this regulation requires EASA to prepare draft implementing rules on Standardised European Rules of the Air (SERA) and to issue an Opinion to the European Commission.

As requested by the amended EC SERA mandate, the development and the consultation of this implementing rule are conducted in close cooperation between EASA and EUROCONTROL.

SERA Part A covered the core part of the draft rule, complemented by a first part transposing ICAO Annex 2 "Rules of the Air" and has been already addressed by the single sky committee. SERA Part B is covering the second part of the work, which is transposing the elements of ICAO Annex 11 which have been identified as being of a "rule of the air nature".

Following the written informal consultation, carried out by EUROCONTROL, that took place between the 12th November and the 6th December 2010, the relevant stakeholder inputs have been taken into account on all aspects of the SERA Part B provisions, and the draft implementing rule has been subsequently improved.

The formal consultation on this additional part of the draft implementing rule followed the EASA Notice of Proposed Amendment (NPA) procedure. It commenced on 10th February 2011 and ended on 10th May 2011. Formal consultation allows all Member States, stakeholders and interested parties to express their formal views on the draft implementing rule.

The request received from the European Commission as well as consultation procedures require to organise a public workshop to discuss the results of the formal consultation. In this context, you are kindly invited to a **stakeholder consultation workshop** which will take place in the EUROCONTROL premises on:
