

## **Management Board Decision**

**DECISION N° 01-2018** 

of 10 April 2018

RENEWING THE TERM OF OFFICE OF THE EXECUTIVE DIRECTOR
OF THE EUROPEAN AVIATION SAFETY AGENCY

THE MANAGEMENT BOARD OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS'), laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup>, and in particular Article 8 of the CEOS,

Having regard to Regulation (EC) No 216/2008<sup>2</sup> of the European Parliament and of the Council of 20 February 2008 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency, repealing Council Directive 91/670/EEC, Regulation (EC) 1592/2002 and Directive 2004/36/EC thereof, hereinafter referred to as "the Basic Regulation", and in particular Article 33(2)(a), 39(1) and 39(4) thereof,

## WHEREAS:

- (1) Mr Patrick KY has been recruited to the post of Executive Director, as a member of the temporary staff, Article 2a) of the CEOS with effect from 01.09.2013;
- (2) The initial duration of his term of office, and therefore his contract of employment, runs for a period of 5 years, which may be renewed for another fixed period of 5 years;
- (3) The European Commission decided in the meeting of its College of 28 March 2018 to propose to the EASA Management Board the extension of Mr Patrick Ky's mandate in accordance with Articles 39(1) and 39(4) of the Basic Regulation;
